Resolution No. 2022-18: Approve Purchase of One Hundred (100) Mackay, Single Space, Parking Meter Housings (Model MKH4000)

## Financial Report: September 2022

Highlights of the financial report for September 2022

- The Yonkers Parking Authority (YPA) has recorded a total of \$449,918 in revenues under the YPA account; \$106,958 under the Buena Vista Garage (BVG) account and \$10,404 at the Cacace Justice Center parking facility during the month of September 2022.
- Operating expenditures for September 2022 totaled \$415,826 for the YPA, \$106,917 for the Buena Vista Garage (BVG) and \$4,885 for the Cacace Justice Center parking facility.
- YPA September 2022 revenues reflected a decrease of six per cent (6%) as compared to figures posted for September 2021; while BVG revenues for September 2022 conversely reflected an increase of five per cent (5%) as compared to figures posted for September 2021.

### Affirmation of Minutes of September 27, 2022 Regular Board Meeting

With Vice Chairman Jerome's arrival and thereby resulting in a proper quorum for the September 27, 2022 minutes, the minutes were brought forth again for affirmation.

Vice Chairman Jerome motioned to affirm the minutes of September 27, 2022 and was seconded by Mr. Gallego. The regular Board minutes of September 27, 2022 were affirmed three to zero, with Mr. Eleutice abstaining due to his absence on September 27, 2022, (3-0, Mr. Vitulli absent).

### **Other Business**

Mr. McLynn briefed the Board about the IPS Smart Meter pilot program where the Authority is testing IPS Smart Meters for a period of ninety (90) days to assess their proposed integration with existing parking meters and Multi Space Pay Stations. The Smart Meters feature a debit and credit card option. On another note, Mr. McLynn remarked that the Authority has been paying the merchant fee charges on credit card usage and was considering whether or not to charge a flat fee to permit parkers.

Chairman Levy asked if there were any other matters of interest for the board. There were none.

The date for the next regular meeting of the Yonkers Parking Authority Board is Tuesday, November 29, 2022.
